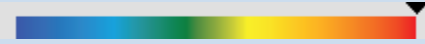

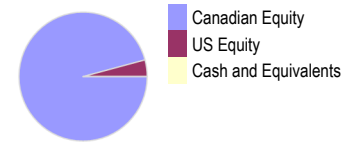

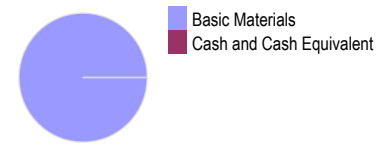
**ASSET ALLOCATION**

as of May 31, 2017



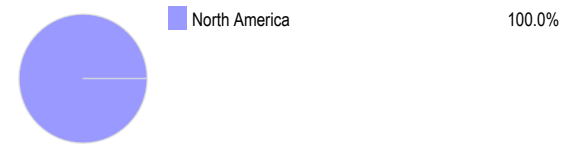
**SECTOR ALLOCATION**

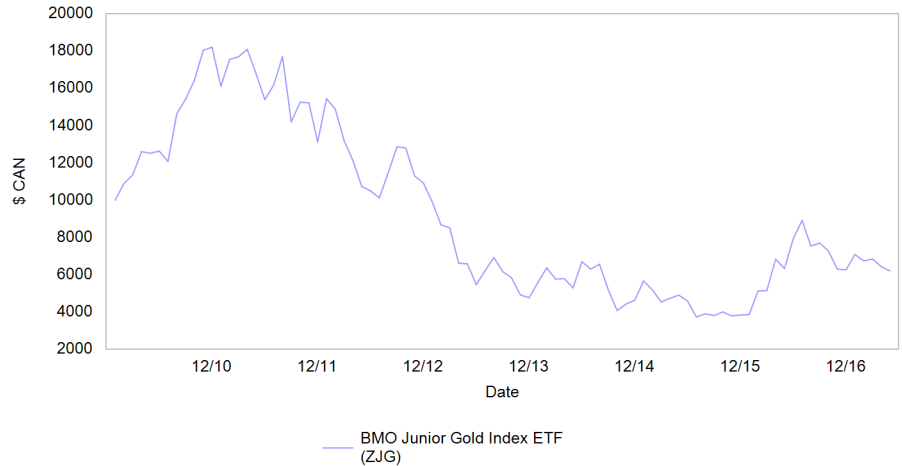
