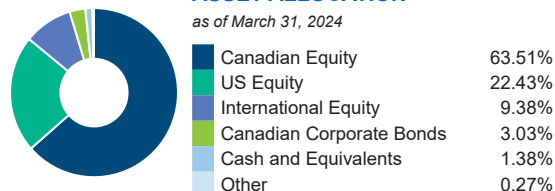

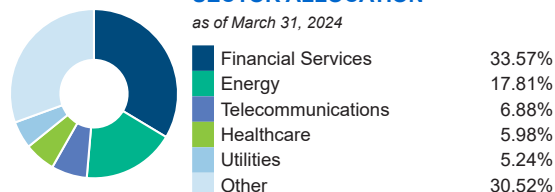
ASSET ALLOCATION
