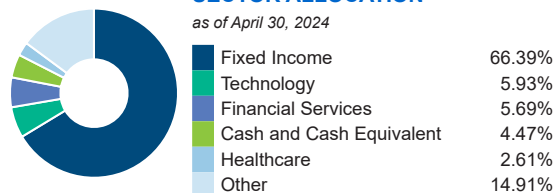
ASSET ALLOCATION

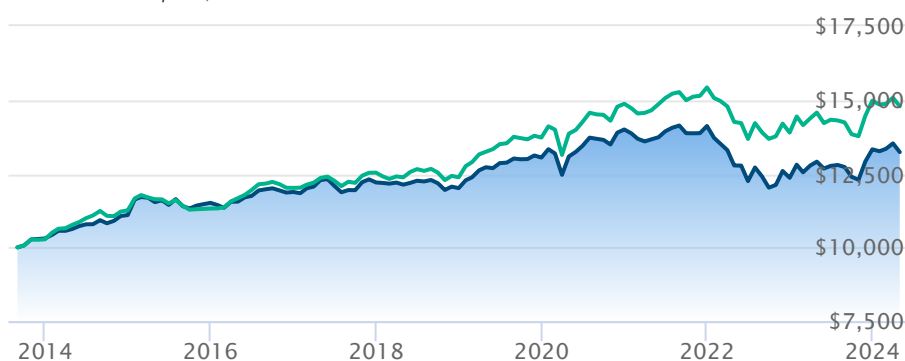
