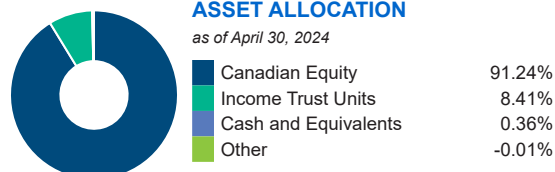

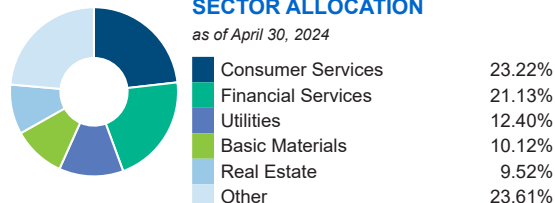
ASSET ALLOCATION
