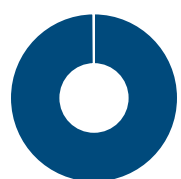

## ASSET ALLOCATION

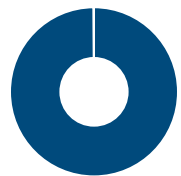
